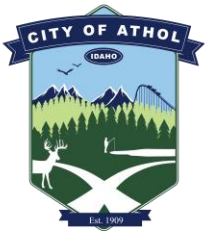

- Inspection required: At any time prior to construction, during construction, or after construction is complete, the City may conduct inspections as necessary to verify the construction is in compliance with the permit and city code.
  
- This permit shall expire if the work authorized by such permit is not commenced within one year from the date of issuance of the permit, or if the work authorized by the permit is suspended or abandoned for a period of one year at any time after the work is commenced.
