- Completed 5 years of audits.

  - Anderson Bros. for the close of 2015 ending September of this year. A forensic audit was completed for the city by Anastasi/Moore/Martin. The city was able to recoup \$102,908 from ICRMP, our City Insurance agent; the other years were denied.

- 3. Set up an Employee Policy Manual and approved it covering employee classification, compensation and benefits.

## A Year in Review, continued...

- 5. The Council also prepared and approved a new purchasing policy.
- 6. In September, Lori Yarborough was appointed by the Mayor and confirmed by the Council as the new City Clerk/Treasurer. And in December the new City Attorney, Randall Adams of Adams and Gaffney in Post Falls was appointed and confirmed.
- 7. The city purchased a PA system for Athol Daze and for rental usage.
- 8. The joint city parking lot was repaided and the community center/city hall building had some repairs: the inside front steps and restructuring of the outside flower beds were completed. JUB did a structural evaluation of the building and it was found to be sound. The kitchen was remodeled from recently purchased kitchen equipment, entailing painting and replacement of sinks and counters. The Grandmothers' Club donated new tables and chairs for the main area downstairs, which helps to create a warm environment. Window repairs, patching the roof and painting of the building were completed also.
- 9. The Council changed the name, Blair Castle Road to N Old Hwy 95, as asked by the citizens.
- 10. Athol's 2nd Beautification and the city's first City-Wide Yard Sale was conducted in June. Numerous volunteers worked with the Mayor on this project.
- 11. The City Council changed its regular monthly meeting date from the first Tuesday at 7:00 p.m. to the third Tuesday of the month at 7:00 p.m.; thus allowing for more time in preparing a complete list of the city's bills accurately.
- 12. The Council passed a compression brakes ordinance, as asked by citizens.
- 13. Athol Daze was a complete success due to the hard work of city employees, Council and numerous volunteers. The Sunday following Athol Daze was Worship in the Park which was attended by 250 or more citizens, this was coordinated by local churches and promoted by the Mayor.
- 14. The latest item was the changing of banks to gain better interest rates for the city and to decrease banking fees.

We feel that through all the issues the city had to deal with this year that a lot has been accomplished. With the hope of numerous opportunities to interact and engage the community and its citizens, we hope to help identify future needs of the city and create a new plan or direction in which to move forward to an even greater 2016. It is unlawful for any child under the age of 18 years to be upon, loiter or stroll upon public thoroughfares or any public place between the hours of 12:00 midnight and 5:00am Monday through Sunday, unless accompanied by a parent or legal guardian.

Trees will be trimmed and/or removed in order to maintain the required clearance distances from our high voltage lines.
