## <u>Update from</u> <u>Mayor Wachter:</u>

• The City has hired a new City Attorney, Mr. John Cafferty with Hawley

Troxell Law offices in Coeur d' Alene. With the addition of John and the City Planner, Rand Wichman, the City is better prepared to do business and get the City back on track.

- The City will be reviewing how to better identify and handle City code enforcement. Issues that arise or are brought to the city's attention and how to handle them have not exactly been as productive as some would hope. There are numerous code violations in the City, and your current elected officials and I hope to begin addressing them. The goal, is to make Athol a great place to live for all the citizens by taking action to promote the health and safety of its citizens.
- There is a Cross Connection Survey inside this month's City newsletter. Please be sure to take a minute to complete this form and return it to the City. It's important that we take the steps necessary to

ensure our public drinking water is safe.

- The City is applying to have a Community Review completed on Athol. This is a huge opportunity to help identify the City's assets and deficiencies. A time to identify priorities for the City and to gain a community perspective. So much has gone on, it's time to come together to create a vision and new direction for the City. We invite you to attend some Council meetings, to keep in the loop and offer direction to your elected officials. More to come as we find out if we are selected, the review will take place sometime in September 2016.
- Fiscal Year 2017 Budget Planning will begin at the end of March (29<sup>th</sup> at 5:00pm) for anyone interested in coming. The council will begin



a series of workshops to further discuss the upcoming budget year. They will identify

**BUDGET** various projects and budget accordingly. The Public Hearing for the FY 2017 Budget Appropriation is currently set for 8/16/16 at 7:00pm.

#### Cross-Connection Control Program: Backflow Prevention

The City of Athol is committed to providing quality and cost-efficient service in the production, treatment, testing and delivery of safe and reliable drinking water to all of its citizens. In order to protect the public water supply against contamination and pollution from cross-connections, the City had implemented a Cross-Connection Control Program as required by the "Idaho Rules for Public Drinking Water Systems." (IDAPA 58.01.08.552.06) (IDAPA 16.01.08 Idaho) and (Ord. 257, 3-2-2004)

What is a Cross-Connection? A cross-connection is any point in the public drinking water system that is actually, physically or potentially connected to a source of contamination or pollution that could enter the system through backflow. Common cross-connections include automatic sprinkler systems, soda fountains, fire suppression systems, and garden hoses, among many others. All cross-connections require backflow prevention.

What is Backflow? Backflow is water and/or other substances flowing in the opposite direction of the normal and intended course. It is the process by which a cross-connection can introduce contaminants into the public drinking water system. In order to prevent potential backflow, some customers are required to install and maintain backflow prevention devices on the main water service lines.

Why should you be concerned? Backflow may affect the quality of the drinking water at your home, business or facility, and has the potential to create health hazards if contaminated water enters your water supply plumbing system and is used for drinking, cooking or bathing.

Protecting your drinking water supply is everyone's responsibility! Community water system purveyors are required to implement and enforce a cross-connection system control program to prevent toxic or hazardous materials from entering the system. But the responsibility for preventing backflow is divided; Public water suppliers regulate protection of the distribution system at each service connection. Water customers have the ultimate responsibility for properly maintaining their plumbing systems. It is the water customer's responsibility to ensure that unprotected cross-connections are not created and that any required backflow prevention devices are tested in accordance with state requirements and maintained in operable condition.

## Preventing backflow situations in your home and business

- Be aware of cross-connections, eliminate or isolate them.
- Maintain air gaps on sinks and when using hoses.
- Do not submerge hoses or place them where they could become submerged.
- Use hose bib vacuum breakers on fixtures (hose connections in the basement, laundry room, and on outside faucets/spigots).
- Install approved backflow prevention devices on lawn irrigation systems and on fire sprinkler system services. Types of preventative required devices will be determined based on the potential type of pollutants or contaminants high, low or moderate.

Did you know ...that Ordinance 257 (2004) was established to protect the public water supply against contamination and pollution from cross-connections?

Last Month, the <u>City's Fees Schedule</u>, was updated and we want to keep you informed. Some of the fees include the following: a full list is posted on the City website at: www.cityofathol.us or you can request a copy at City Hall.

<u>Miscellaneous: Building / Office Fees:</u> We can now make copies and faxes for a minimal fee. \$0.10 black and white, and color copies are \$0.15 each. Faxes can be done for \$1.00 for the 1st page and \$0.50 for each page thereafter. In addition, there will now be a \$20.00 return check fee for any check written to the city that is returned for non-sufficient funds.

<u>Building Room Rental Rates</u>: The big changes are, we now offer a Full-Day (6+ hours) and a Half Day (up to 4 hours) rate. In addition, we have a PA System that can be rented for your use at your event, while at the Community Center.

<u>Planning & Zoning Fee Schedule</u>: A number of these fees were increased, as they had not been in nearly 25 years. They now reflect a more accurate cost to actual costs incurred by the city to carry out the request. Most are related to new development and land use, however, one to note is the Site Disturbance permit. It now costs \$40.00 for all Site Disturbance permits, and there will be a fee charged (double the fee for the permit) when there is failure to first obtain a permit.

<u>City Sponsored Special Event Fees:</u> These are mainly related to events such as <u>Athol Days</u>.
