# Are <u>YOU</u> interested in Public Service, <u>serving on the City Council</u>?

We are now taking letters of interest for the City's Council Position #3. City Council President, Mary Zichko, has been appointed by the council to serve the remainder of Mayor Wachter's term. It is the role of the Mayor to now make an appointment to fill the vacant council position #3. This person would serve on the Athol City Council until elections next November 2019. Once elected, it will be a 2-year term.

In order to seek the appointment of Council Position #3 of Athol a person must be registered to vote in the city of Athol at the time the person applies. (I.C. 50-601) In addition to what is required there are things that will disqualify a person from being able to serve on the council. (I.C. 34-403) *Please contact City Hall if you have questions regarding being a qualified elector.* 

If you are interested in serving your city, on the council, please submit a Letter of Interest with your name and address, that states what your future vision for the city is and why you would like to serve as a member of the Athol City Council.

The Mayor will review all the applications and make her appointment at the October 16<sup>th</sup> regular City Council meeting. Please submit letters to City Hall 30355 N 3<sup>rd</sup> Street no later than Thursday, October 11<sup>th</sup>, 2018.




Every effort will be put into keeping the public informed on decisions made by the council and concerns of the citizens. I'm willing to listen to anyone.

For those who don't know me I have lived in, Athol 45 years, have been a member of the Council and President of the Council for the past 5 years. I was Citizen of the Year in 2011 and worked for the food bank & clothing room for about 4 years. I have also started up the Neighborhood Watch program and was a member of the Grandmothers Club. Previous work history includes 25 plus years in government offices. I am a mother of 5, & grandmother of 15.

Through this newsletter I will try to keep you updated and informed on matters concerning the city. Please feel free to contact me on issues you are concerned about.

- ➤ <u>City Nuisances (Athol City Code 3-1-1):</u> I ask all residents to please do their best to cleanup your properties, especially in the right-of-way areas. We would like to see everyone do their part, and we hope to not get to the point of the city needing to take a more formal action.
- The Income Surveys have been collected, preliminarily we have achieved the required 51% or greater for the income levels and will be ready to move forward with the Idaho Community Development Block Grant application once we find out if the Water Bond passes at the November 6<sup>th</sup> Election. Thank you to everyone who took a minute to complete the survey and send it in. This was one of the hurdles for the City to be eligible for grant funds to help with water infrastructure improvements. Thank you.
- ➤ <u>Bond Election this November:</u> There will be a Bond Election before you this November for water infrastructure improvements. Come and be informed on what it's about at the Town Hall Tuesday, October 23<sup>rd</sup> at 7:00pm at the Athol Community Center.
- Please help me in congratulating our City Clerk/Treasurer, Lori Yarbrough, in her achievement of becoming certified as a Municipal City Clerk/Treasurer for the State of Idaho. Lori has been attending conferences and various trainings over the past four years that she has worked for the city. She is also just starting her last year of a two-year term serving localy in our District, as the 1<sup>st</sup> Director of the Idaho City Clerks, Treasurers, Finance Officers Association (ICCTFOA).
