# A RESOLUTION OF THE CITY OF ATHOL, KOOTENAI COUNTY, IDAHO ADOPTING CITY OF ATHOL'S FEE SCHEDULE

WHEREAS, the City of Athol has reviewed all fees charged for services; and

WHEREAS, the City of Athol has determined that periodic revisions to fees may be necessary.

WHEREAS, the City has fees for service already established; and

WHEREAS, the City of Athol has determined that the fee schedule be amended to reflect the reasonable cost of providing the services; and

WHEREAS, after public hearing on April 16<sup>th</sup>, 2024, has been held prior to the adoption of this resolution, in accordance with Idaho Code Section 63-1311A, regarding new increased city fees, it is deemed by the city council to be in the best interests of the City of Athol and the citizens thereof that the fee schedule be amended to include the new and increased fees which were addressed in the public hearing.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Athol, Idaho that the following fee schedule, which reflects the new and amended fees; and the existing fees that have not been amended, be adopted effective the 16<sup>th</sup> day of April 2024:

- ➤ Water Service Availability Fee (Connecting to city water system) \$1,200.00
- > Water Tap Fee (new water meter installation) \$3,750.00 for 1"; \$6,800.00 for 2"; anything larger than 2" must be approved by the council. (This is generally a new service.)

\$850.00 Excavation-Labor/testing;

\$2,300.00 Parts/Meter Setter Box (coil pit, saddle, setter box, etc.)

\$600.00 Water Meter & Radio Node

\$3,750.00 for 1"; 2" is proportional to the 1" costs. The City of Athol staff shall have the power to vary and/or waive the applicable fees established in this resolution regarding water tap fees. (Depending upon level of development.)

- Additional Extension/Road Bore Fees may apply to certain lots. The entire cost goes to the land/homeowner. (If water lines run on the opposite side of the road from meter)
- ➤ Commercial Re-hook up Fee \$950.00; Residential Re-hook up Fee \$450.00 (Happens when meter was removed and wanting to reactivate. Removing a meter is the only way to not pay a monthly bill.)
- ➤ Meter Tampering Fee \$50.00 plus damages if applicable.
- > Any Commercial Bulk Account that is 90 days or more past due will be suspended from use until balance has been paid.

City staff is directed to take all administrative actions necessary to implement the listing of effective City fees. Any fee inconsistent with the provisions of the Resolution is hereby repealed or superseded to the extent of such inconsistency, as appropriate.

This revised fee schedule shall be effective beginning April 17, 2024 unless the authorized date is otherwise indicated in the Resolution and shall remain in force until revised by subsequent Resolutions of the City of Athol City Council.
