- You may **NOT** turn water on or off at City’s valve.
- All work performed on the meter must be done or coordinated by the City.
- Meters remains the sole property of the City.
- We recommend installing a shut-off valve between the meter & your home.

Billing:

Statements are mailed at the end of each month, and are due on upon receipt of bill, or no later than the 15th of the month. Late fees will be assessed as of the 16th of each month. **Rates:** All water accounts are billed according to meter reading usage:
