
PRESENTATIONS / DISCUSSIONS:


- 1) **ATHOL HISTORY/TIMELINE** on how we got here was given by Councilman McDaniel.
- 2) **TIMBERLAKE FIRE DISTRICT CHIEF** Bill Steele spoke briefly about response on recent commercial fires, the impact of the Howard Street well and to citizen insurance ratings. He made a statement that a “better water system lowers the risk of firefighter safety.
- 3) **CITY ENGINEERS, KELLER ASSOCIATES-** Stillman Norton P.E. & Kyle Meschko P.E. went through a power point presentation with miscellaneous overall review about the project itself and possible funding strategies.
- 4) **IDAHO DEPARTMENT OF ENVIRONMENTAL QUALITY (DEQ)** – Katy Baker-Casile P.E. spoke to the funding and regulatory side of things, sharing the concern of if depressurizing occurs it heightens health risks to the community.
