

<u>Update from</u> Mayor Wachter:

• We will begin reading water meters this month, which means some of you

might see a little larger bill if you have a leak. Depending on the weather and temperatures, water meters are generally last read in Sept./Oct and we begin reading them again in April.

Please call City Hall, 208-683-2101, if you have any questions or need some pointers on what to look for in the event of a water leak.



- We are still reviewing how to better identify and handle City code enforcement. This is likely to bring about some changes that affect our citizens, but, I hope that you will all see the importance of being consistent and that we care about how the city looks and you should too.
- We also want to share that the City does stay in compliance with the water testing requirements and tests for Lead in the City water every 3 years. In light of what the City of

Flint, Michigan has gone through, I wanted to assure you we are staying up to date with all our testing. We also stay up-to-date with the training/certifications and education that is necessary to ensure our public drinking water is safe.

- Your City Staff and Elected Officials have attended several meetings and trainings this past month covering areas from water safety to the Association of Idaho Cities who give a tremendous amount of information, support and trainings on the numerous laws and procedures required of cities.
- Fiscal Year 2017 Budget Planning will be continuing for anyone interested in coming. The next

council workshop will be Tuesday, May 17, 2016 at 5:30pm. They will continue to discuss and identify various projects and budget accordingly. The Public Hearing for the FY 2017

Budget Appropriation is currently set for 8/16/16 at 7:00pm.

Cross-Connection Control Program: Backflow Prevention

72 of the 305 surveys (approx. 23%) have been turned in so far, please remember to get those turned in as soon as you can. Thanks ©

Also, a reminder to all businesses in the city, as well as, those residential homes who are required to have your backflow connections inspected every year, be sure you or the company doing the backflow inspection, provides a copy to the city.

New on your Water Bills: You will now see two line items on your water bills. The first line is for the Base Rate, for example, a single residential unit will



read the \$13.50 (up to 15,000 gallons) and the second line will read the dollar amount of the overage. (This second line is calculated at \$1.10 for every additional 1,000 gallons used beyond your base rate.) Please don't hesitate to call City Hall, 208-683-2101, if you

have any questions or need any further assistance in reading your bill.

Water bills are mailed out in the last week of each month and are always due by the 15th of the month. We are not allowing water bills to go past 60 days due. If it gets shut-off, there is an additional \$25.00 fee to turn your water back on. We do accept payments by credit card and you can pay ahead.



Did you know ...that City Code (Ordinance 263) only allows for one residence per parcel? To have a second residence, the property first needs to be divided through the City's subdivision process. In order to subdivide, you'll need to have approval for a second septic system (often called a sewer ER). The process is somewhat involved, but the City now has a planner that can help you understand it, if you are considering subdividing.

Reminder: Site Disturbance Permits now cost \$40.00, and there will be a fee charged (double the fee for the permit) when there is failure to first obtain a permit. Applications can be picked up at City Hall or found online at www.cityofathol.us, under documents and forms.
