Unfinished Business:

Panhandle ER information* Panhandle Health would like acceptance letter.

*Panhandle Health does not want to ask/talk to their board if we ask for more after they do/if the do five us more ERs for our pool. Depending how you read potentially 93 ER's needed/we have roughly 50 ERs now, there are still undeveloped lots and 93 ERs would cover all of the lots in town. Panhandle Health is willing to deal looked at our over all water usage. Need motion and vote by the City Council that they are willing to negotiate new SMA agreement. Just need to be clear if we ask for certain amount. We will not ask for more then recommended new SMA agreement. Councilwoman Zichko made motion to negotiate SMA agreement, and provide letter that indicates Council voted to negotiate new agreement. Second the motion made by Councilman Spencer. Miller-Aye, McDaniel-Aye, Ayes unanimous.

JohnHartung Community Library Network, removal of tree.. Has estimate *Quote from Jacobsen tree service \$3,300.00 Seems a little high. Councilman McDaniel asked for what cost would be just to bring down the trees only, not removal of them. Also, KEC still has not gotten back regarding if they would help remove the trees beings there are electrical lines in location as well. Will table this discussion until we have more information on pricing.

Art Luckado, discuss 3rd/Miller Mel Bertch property fix road where it floods, water gets very deep. Safety issue.

*Mel Bertsch would like to discuss Bertsch Rd and 3rd Street property Mr. Mel Bertsch introduced himself and it had been brought to his attention that there were complaints about the quality of the road and it being a safety issue. In discussion with Mr. Bertsch's attorneyhe advised Mr. Bertsch the best in Mr. Bertsch's interest would be to just close the road and not allow any vehicles to come through, then Mr. Bertsch would be protected. If the city does not want to take on the liability of the road it is just best to close down. To bring the road up to code would run about 300,000.00. Mr. Bertsch feels that since he owns the road, he has the right to close the road. It is not in the cards for the city financially. So as it stands, Mr. Bertsch feels best in closing the road. Our City Attorney did advise of State Law indicating if the road is used and or maintained by the public for 5 years, the city can take over if they would

like but it would be a huge expense. The city recognizes there is a big liability and not in their best interest to take over the expense of the road.

• Input on the old City Hall building — What to do restore?

Councilman Miller inquired how old does a building have to be before it is deemed historical? Maintenance worker Stephen Williams had gotten a bid to see cost on repairing and it was right around 16,000. Councilman Spencer asked what do we want to do with the building? Save it as historical or as Mayor Kuhman suggested restore for possible concession stand? Councilman Miller had indicated in the past he brought up possibly having a group of volunteers to restore the old City Hall, there are lots of memories and it is basically the only historical building left in Athol. Gentleman in the audience Seth McDaniel spoke up, he is not a resident but grew up here and majority of his family Athol residants would volunteer to help do work to restore building. Another gentleman in the audience who owns a business in Athol City Art Luckado stated he could possibly work on getting some concrete donated. Would need to get a group of volunteers in order and scheduled to do the work. Stephen and possibly Seth will scope and see what needs to be done.

Connie would like to make sure she can keep 2nd ER she indicated there was
paperwork stating there was a trailer on the property in the 1960s. Informed Ms. Stone
