#### **ACTION ITEMS:**

- 1) APPROVAL OF THE September 18<sup>th</sup> REGULAR MEETING MINUTES: Motion by Hill, seconded by Spencer that we approve the last regular meeting on the 18<sup>th</sup>, minutes with/without amendments. \*DISCUSSION All in favor- Motion passed. ACTION ITEM
- 2) APPROVAL OF THE September 14<sup>th</sup> SPECIAL MEETING MINUTES:

  Motion by Hill, seconded by Spencer that we approve the minutes for the workshop/special meeting on the 14<sup>th</sup>, minutes with/without amendments- this was to discuss with the varying agencies the preparation for the upcoming Town Hall for the Bond Election and education. \*DISCUSSION All in favor- Motion passed. ACTION ITEM
- 3) APPROVAL OF BILLS AS SUBMITTED: <u>Motion by Spencer</u>, seconded by Hill that we approve paying <u>Sept/October bills as submitted with/without amendments</u>. \*DISCUSSION-All in favor- **Motion passed**. ACTION ITEM
- 4) DISCUSSION/APPROVAL of Tire purchase for the 1992 Chevy, city truck. Motion by Spencer, seconded by McDaniel that we approve the purchase of 4 new tires for the city truck; allowing Anthony to see if he can get a bargain from Mr. Tire to give him the business, but with the Mayors discretion pick who you want.
  \*DISCUSSION- Roll Call: Hill-yes; Spencer-yes; McDaniel-yes; Motion passed. ACTION ITEM
- 5) APPROVAL of RESOLUTION 2018-02 Fair Housing as needed for the Community Development Block Grant Application (CDBG) Motion by Hill, seconded by McDaniel to approve Resolution #2108-02 on Fair Housing. \*DISCUSSION by Nancy Mabile with Panhandle Area Council (PAC). Councilman Spencer would like to rescind this resolution in the event the Bond Election does not pass. Roll Call: Hill-yes; Spencer-yes; McDaniel-yes but doesn't really like the Fair Housing implications; Motion passed. ACTION ITEM
- 6) APPROVAL of RESOLUTION 2018-03. Citizen Participation Plan as needed for the CDBG application. Motion by McDaniel, seconded by Hill to approve Resolution #2108-03 on Citizen Participation Plan. \*DISCUSSION by Nancy Mabile with Panhandle Area Council (PAC).

Roll Call: Hill-yes; Spencer-yes; McDaniel-yes; - Motion passed. ACTION ITEM

Nancy then took a moment to give the council an update on the Income survey, sharing that we have received enough surveys to count and qualify, but will keep it open and accept surveys before submitting to the

department of Commerce. She also gave the council a brief rundown of the information that is included in their approval of authorizing the Mayor's signature when its time to submit the block grant application.

- 7) APPROVAL/RATIFICATION of the Mayor's signature for professional services with Keller Associates for the work of creating a Transportation Plan. This is to be funded by the LHTAC grant for \$50,000.00 we received. Motion by McDaniel, seconded by Spencer that we approve the mayors' signature on the billing contract with Keller for the Transportation Plan. \*DISCUSSION Roll Call: Hill-yes; Spencer-yes; McDaniel-yes; Motion passed. ACTION ITEM
- 8) APPROVAL of RESOLUTION 2018-04 Inter-fund Transfer for the FY2018 from the General fund to the Street fund; and identifying committed funds in the General and Street fund balances. Motion by McDaniel, seconded by Hill to Approve Resolution #2018-04 an Inter-Fund Transfer of \$40,523.00 from the General fund to the Street fund; and committing \$5,000.00 for Reserves/Savings in general fund of the net position; also committing \$7,800.00 to Future Street Improvements (chip sealing) and \$1,000.00 to Future equipment both in the street fund of the net position. \*DISCUSSION Roll Call: Hill-yes; Spencer-yes; McDaniel-yes; Motion passed. ACTION ITEM
- 9) APPROVAL of RESOLUTION 2018-05 Inter-fund Transfer for the FY2018 from the Street fund to the Water fund. Motion by Spencer, seconded by Hill to Approve Resolution #2018-05 an Inter-Fund Transfer and repayment of \$39,323.00 from the street fund to the water fund as the final repayment for paying off the loader; and committing \$4,000.00 to Future Equipment and \$5,000 for Reserves/Savings both in the water fund of the net position; and commit \$25,000 of the water fund net position to Capital Improvements in the Water fund.\*DISCUSSION Roll Call: Hill-yes; Spencer-yes; McDaniel-yes; Motion passed. ACTION ITEM
